## **Requirements for the thesis of report:**

- volume 2-5 pages. Format A-4 in the text editor Microsoft Word for Windows 6.0, 7.0, 97, 2000, 2003, 2007; font (typestyle) Times New Roman, size 14; line spacing 1,5; paragraph indentation 1.25 cm; margin 2 cm;
- -sequence of placement of materials in the theses of the report: the direction set according to the subject matter of the abstract, the author's surname and initials (bold type); scientific degree, academic rank (if available), position, place of work (study); city where the educational institution is located; the country; name of theses (capital letters, font bold); text;
- the file name must be signed in Ukrainian according to the surname and initials of the participant of the conference;
- -references for literature (without repetitions) are made at the end of the text under the title "Literature:";
- footnotes are indicated in the text by square brackets with the definition of the serial number of the source per the list and the page numbers (pages) are indicated by a comma, for example: [1, p. 45].

The Organizing Committee has the right to reject the thesis of the report if it does not correspond to the subject matter of the event.

The authors are responsible for the content of the theses of reports and presentations.
